Types of Membership

Associate Membership

- Receive a glossy magazine 3 times per year

- Can not exhibit at shows
- You are not listed under the Directory of members on the website.
- Does not permit herd or animal registration

Partner/Corporate/Individual Membership

- Receive an information pack (which is a large folder) with all information on alpacas. The topics cover everything from health issues to what type of fencing is required for alpacas. This information is invaluable to anyone who has alpacas, be it two wethers or twenty females. Keeping your animals healthy and treating them correctly prevents disappointments later.
- Receive all correspondence, information and updates
- Receive a glossy magazine 3 times per year
- Receive the bi-monthly newsletter
- Can register a stud name, as alpacas have a pedigree registry
- Can register eligible alpaca on the IAR(NZ) once a stud name has been registered
- Have a right to vote at AGM and SGM or via postal voting
- Can be elected for Council and committees
- You can exhibit at shows

Herd Prefix

Your Herd Prefix is used as a prefix to, and as part of the name of the alpaca you register (eg. Green Park Jason). Many breeders use their property name as their Herd Prefix. However, the Herd Prefix of any herd must be unique within the Alpaca Association NZ Inc. Choice of Herd Prefix (submit two, each of 16 letter max – includes spaces if more then one word.)

Herd Code

Up to three (3) alpha or numeric characters used to identify your herd. The Herd Code is the first part of the Ident Number of animals born in your herd (eg. GPA may be assigned as the Herd Code and the first alpaca born in 2007 would be GPA C0001). Choice of Herd Code (submit two up to 3 letters)
